

# Privacy Policy

This Privacy Policy explains how we collect, use, disclose, and protect personal information when you visit or use our website, products, services, memberships, or related features.

## 1. Information We Collect

We may collect the following categories of information:

- Operate referral, rewards, loyalty, or sponsor programs.

## 4. Service Providers and Business Partners

## 6. Cookies and Tracking Technologies

We may use cookies, pixels, local storage, and similar technologies for the following purposes:

- Essential cookies required for core website functions.
- Affiliate or referral tracking technologies used to credit referrals or commissions.

You can often control cookies through your browser settings, although disabling certain cookies may affect website functionality.

## 7. How We Share Information

We may disclose personal information to service providers, payment processors, vendors, professional advisers, business partners, regulators, law enforcement, or other parties when reasonably necessary to

operate the website, complete transactions, protect rights and safety, comply with law, or carry out a merger, sale, financing, or transfer of business assets.

**Sale of personal information:** We do not sell personal information in the ordinary meaning of the word.

**Email lists:** We do not rent or trade email lists.
